Athletic Therapy Ontario takes its role and responsibility in supporting continuing professional development for its Members. Like all health care professionals, Athletic Therapists are committed to lifelong learning and the advancement of their knowledge and skills to ensure evidence-based practice.

The OATA has developed professional education opportunities with a range of partners and alliances to offer online, e-learning through the first Athletic Therapy online academy in Canada. OATA Members are also encouraged to develop courses, webinars, lunch-and-learn virtual sessions the OATA can promote and recommend to their Member colleagues.

Health Care Continuing Education

Health professionals serve as the bridge between patients, the knowledge generated by scientific research and the policies and practices to implement that knowledge. The public trusts health professionals to provide care that is safe, efficient, effective, timely, patient-centered, and equitable.

Health professionals in Ontario graduates after extensive formal education, followed by a process of certification of competencies and often registration with a regulatory health care college. Continuing education (CE) is a post-grad and post-professional designation commitment that continues the duration of a health professional's career. CE serves two functions: maintenance of current practice and translation of knowledge into practice.

Educating professionals about new theories and evidence of what does and does not work, and under what circumstances, is one part of promoting the provision of better health care

Life-long learning is rooted in the position that learning occurs along a continuum. CE units might be required to attain credits for the licensure and credentialing to practice, or, if regulated health care professionals, CE is mandatory as part of annual self-learning commitments to maintain competence and improve quality of care delivered. Regardless, for the OATA, it is a commitment to supporting the advancement of the AT scope of practice.
